- **3.** Year End Audit Recap: The 2023 HHL financial audit was reviewed and a motion by Dave to approve, seconded by Dan Unanimous
- 4. January 24 February 29 Treasurer Report: One miscellaneous expense of \$225 to Mi Corp (water testing) Motion to Approve by Dom, Seconded by Dave Unanimous
- 5. 2024 Lake Association Budget: The 2024 annual budget was reviewed and a motion to approve was made by Paul and seconded by Bruce Unanimous.

OLD BUSINESS

1. Lake Ecology / Fish Management:

- a. Terry and Bruce will survey some areas where *Evasive Weed Species* are known to be located and see how they made it through the mild winter.
- b. The phosphorus tests have arrived and Terry will test the water ASAP.
- c. Ice out this year was on February 29^{th}
- d. Dave had a resident ask why there is no pike size limit on the lake. The regulations were set by the D.N.R. The D.N.R. has now extended the no size limit to other lakes.
- e. The D.N.R is now looking at testing Bluegill size slotting limits.
- f. Fish Study The last lake / fish study was done in 2000.
- g. A motion was made by Don to develop a plan to have a Lake / Fish survey done on the lake. The plan would include how we fund having a professional company conduct the survey in 2025. The plan was seconded by Dave – Unanimous
- h. Terry and Dan will attend the MLSA conference on April 26-27 in Muskegon
- i. Wake Boat State Legislator bill: Bill 5532 is now in legislation. This bill would limit wake boats to at least 500ft from shore and in waters deeper than 20 feet. Lake residents can contact our house of representative Tom Kunse at 517-373-7317 or through email at <u>tomkunse@house.mi.gov</u> with their thoughts on the bill.

- 2. Community Outreach Items for Newcomer Flyer: No news to report. Jade would welcome new ideas to reach residents.
- **3.** Membership: YTD, we have 21 members. We expect the total membership numbers for 2024 to be similar to 2023.
- 4. Communication/Newsletter: Mike brought up an option to print our newsletter in color. He will continue to look at what it would cost compared to our current B&W version. Cathy and Cheryl Haywood will also look at ways to cut cost of printing and mailing. This will be tabled until the April meeting.
- 5. Lake Water Levels: No update- levels are still at winter water levels.
- 6. Goose Nest and Egg Destruction permit: Application has arrived and Mike will complete it. Any lake resident can participate in the program. Residents that participated last year do not have to reapply.
